Terms & Conditions

All students participating in Latin Vibrations' classes, courses, workshops and events (collectively referred to below as 'activities') must agree to the following Terms and Conditions. Latin Vibrations reserves the right to amend these conditions or add new conditions as it deems to be reasonable and necessary.

General

Liability: Students acknowledge that while attending a Latin Vibrations activity either at the studio or any other location, Latin Vibrations is not responsible for any loss or damage to students' personal property. Students recognise that participating in any Latin Vibrations class, course, workshop, performance or other event may involve strenuous physical activity including, but not limited to, cardiovascular conditioning and interval training, muscle strength and endurance training, and other various fitness activities. Students understand that it is their personal responsibility to consult with a physician prior to and regarding participation in Latin Vibrations' dance or dance fitness classes. Students fully understand that injury may occur as a result of participating in any dance activity, and forever release Latin Vibrations and its agents from any claims, demands, and causes of action as a result of the student's voluntary participation, and from any liability (including liability for their negligence and the negligence of others) now or in the future for conditions that the student may obtain. Students are fully aware and agree to assume full responsibility for any risks, injuries or damages, known or unknown, which might be incurred as a result of participating in dance activities.

Footwear: Students must wear appropriate footwear and clothing for their class: supportive, covered footwear (e.g. joggers or dance sneakers) for dance fitness classes, heels or flats which are secure around the ankle for other dance styles. Thongs and sandals are not appropriate for any type of class at Latin Vibrations.

Safety: Students agree to follow all reasonable and lawful directions provided by Latin Vibrations and its agents, including signage at the studio and other written and verbal directions.

Image: Students' image may appear in print, electronic or video media produced by or for Latin Vibrations for advertising and/or promotional purposes. Latin Vibrations must be informed upon the student's arrival at the studio if the student does not wish for their image to be used. LV does not have control over the use or reproduction of students' images at public events.

Minors: Any student under the age of 18 must have parental/guardian consent and supervision to participate in Latin Vibrations activities. Some classes are off limits to anyone under 18 years of age. Latin Vibrations reserves the right to exclude students from some dance styles on a case-by-case basis, based on their age.

Refund Policy

Casual Attendance: The choice of refund or credit will be offered in the event that a casual fee is paid and the class is subsequently cancelled for any reason. Latin Vibrations does not refund the casual fee if a student is dissatisfied for any reason with a class they have attended.

All-You-Can-Dance Membership (Month, Quarter, 6-month, or Annual membership fees): No refunds or credit will be given to students who change their mind about membership after the cooling off period. Memberships are not transferable. If a student a) suffers an injury which prevents them from participating in dance activities for longer than 3 months, b) moves away from Townsville, or c) falls pregnant, after the membership has begun, special consideration will be given and any possible refund or credit will be offered on a strictly case-by-case basis. Latin Vibrations' decision will be final. 'Hold' periods of 3 months or less may be offered; see 'Membership' section of the Terms and Conditions. Latin Vibrations reserves the right to calculate the value of the refund or credit in the most appropriate way it sees fit.

Shine Your Light Membership (Unlimited, 4-per-year or individual course membership fees): No refunds are given due to absences from course rehearsals in which the student is enrolled. No refunds or credit will be given to students who change their mind about membership after the cooling off period. Memberships are not transferable. If a student a) suffers an injury which prevents them from completing the course in which they are enrolled, b) moves away from Townsville, or c) falls pregnant, after the membership has begun, special consideration will be given and any possible refund or credit will be offered on a strictly case-by-case basis. Latin Vibrations' decision will be final. Latin Vibrations reserves the right to calculate the value of the refund or credit in the most appropriate way it sees fit.

FOR UNLIMITED SHINE YOUR LIGHT MEMBERS ONLY: 'Hold' periods of 3 months or less may be offered; see 'Membership' section of the Terms and Conditions.

FOR 4-PER-YEAR OR INDIVIDUAL COURSE MEMBERS: If injury, serious illness or an unforeseen change in circumstances prevents the student from completing a course, a full or partial credit will be offered, to be used in a timely fashion.

Admin Fees: Cancellation of membership during or after the Cooling Off Period will attract a \$20 admin fee. Suspension of membership of any duration will attract a \$20 admin fee.

Membership

One-month memberships must be paid upfront in full. Quarterly, 6-monthly and Annual memberships may be paid upfront in full or with Ezy pay recurring direct deposit payments (additional conditions & fees apply).

The Cooling Off Period begins when the client signs the agreement and ends 48 hours after this time. Request for termination of membership during the cooling off period must be in writing.

Any application by a student to cancel or place a 'Hold' on their membership must be in writing.

Students may opt to upgrade their membership at any time before the end of the membership period, and pay the difference as determined by Latin Vibrations. Upgrading requires the membership period to start anew. Downgrading memberships is not allowed except at the time of renewal.

Membership may be revoked by Latin Vibrations in the event that a student acts in breach of the code of conduct or in a way that presents a danger to themselves, other students or LV agents.

If a performance course does not have enough students it will be cancelled and you will be informed. If this happens, only individual course fees (\$150 payment for a single course) will be offered a full refund. Individual course participants and SYL members may choose to transfer to another course.

If the student fails to make any membership payments, they may be refused entry into the studio until such time as all outstanding payments have been received. Late fees may also apply as prescribed by management from time to time (Ezy pay also imposes its own fees for missed payments). Prolonged non-payment of fees will result in cancellation of membership and possible legal action to recover any outstanding monies owed. In addition, the student will be required to pay any reasonable legal costs and outlays and/or debt collection fees incurred by Latin Vibrations.

Latin Vibrations reserves the right to amend the hours of operation, Class Timetable, dance styles offered, fees, charges, membership terms and conditions in accordance with the changing requirements of the studio.

Performance

Costume costs are not included in performance course fees. Costume costs vary; Latin Vibrations endeavours to keep expenses as affordable as possible.

Latin Vibrations reserves the right to disallow participation in performances if rehearsal attendance or behaviour are inadequate.

Students in performance courses are required to inform their Instructor of any absences from rehearsals. If a student can no longer participate in the performance, notice should be given as early in the course as possible.

Students enrolled in Brazilian Samba performance courses or development programs are not permitted to perform for or represent any other dance school in Brazilian Samba.

Students enrolled in Burlesque development programs are not permitted to use material created at LV to perform for or represent any other dance school, unless permission is given by Latin Vibrations.

Code of Conduct

Students agree to comply with staff recommendations and instructions regarding safe dancing and equipment use (including chairs and dumbbells).

Students agree to be courteous and respectful to all other students and staff.

Students are required to respect the studio property and premises.

Students are required to moderate their language, conversation and behaviour when they are representing the studio.

Students are required to clean up after themselves and maintain clean studios and amenities.

Students are required to be respectful when other classes are taking place.

Students should refrain from instructing fellow students. Any issues must instead be directed to the Instructor.

Appropriate clothing must be worn, including footwear, and coverage should be adequate so as to not offend other members or staff.

Students agree not to reproduce images or video of fellow students or LV agents for public viewing without the expressed permission of each individual.

Stealing is not tolerated and will result in immediate expulsion from the school. Whether direct acquisition of another person's property, not paying studio fees or not enrolling in classes/paying the required fees of the course without prior agreement.

This code of conduct is in place to ensure maximum enjoyment for all students at Latin Vibrations.
